## Description

- ♦ Refer to IFP4E Fire Alarm Control Panel Installation Manual
- As ZCP board of GST-IFP4E, ZC-400FE Zone Display and Control Board (RY color) can control indictors and be used to input keys.
- P-9981FE contains ZC-400FE board and panel (without keys), which can only display indictors.
- P-9982FE contains ZC-400FE board and panel (with keys), which can control indictors and be used to input keys.
- 1) Cascade Port: XS2, XS3, XS4
- Indicators: HL1~HL40 indicators light red and yellow in turn as GST-IFP4E control panel tests itself.

# **Connection & Wiring**




Fig. 1 Cascade Connection

### Installation

ZC-400FE Zone Display and Control Board (RY color) is installed on the P-9981FE panel (without keys) or P-9982FE panel(with keys). Install that on to the GST-IFP4E according to the " † ". Then fix it with two screws.





Fig. 2 ZC-400FE Zone Display and Control Board (RY color)

P-9981FE P-9982FE Zone display and control panel is installed on the cabinet door. The following Fig.4 shows how to install it.



First, Align the snap of the zone display and control panel with the slot on the door; Second, Hook the zone display and control panel with the door; Finally, fix the panel with screws.

#### Set Address

Put the code switch of SW1 (as shown in Fig.2) to the side of the number. Actual address= Address of the Code Switch +1.

For example: If the actual address is 2, dial the code switch to the side of number 1. If the actual address is 1, there is no need to dial the code switch.

#### Installation of Labels

Installation steps Fig.5 are shown below for labels on the ZCP.

Take the transparent baffle from the ZCP by using a small screwdriver. Put the printed label into the slot for ZCP label and then restore the transparent baffle. Maximum 8 locations can be installed with P-9981FE or P-9982FE Zone display and control modules.


